

He also informed the members that feedback on internships is taken from both students & companies & suggestions are asked for any improvement if required.
4. To inculcate innovative culture amongst students & faculties & to increase the industry interaction, the august house suggested that the students as well as faculties should be encouraged for patent filing, good hardware projects & new ideas.
5. After discussion, it was decided that project innovation competitions should be arranged for students at institute/department level & some experts especially from industries may be invited to look at these projects & ideas, so that students will also be benefitted by their suggestions & there will be good industry-institute interaction. All the members welcomed the decision.
6. It was also suggested by the chairperson to arrange some STTP's, guest lectures of industry persons so that these can give a practical knowledge to the students.
7. Also the panel was advised to register for Smart India Hackathon, an initiative by Govt. of India as an effort to improve innovation by encouraging students to apply knowledge to real-life situations and find innovative solutions.
